






# Michigan: A State Profile








Data shows about 17% of individuals with I/DD who receive CMH services use a fiscal intermediary to manage payments for their community mental health supports.






- Supports the principle of "Authority"

- Helps the person direct their services and supports





#### Percent of Individuals Receiving CMH Services with a Fiscal Intermediary (2010)








#### Percent of Individuals Receiving CMH Services with a Fiscal Intermediary (2011)








#### Percent of Individuals Receiving CMH Services with a Fiscal Intermediary (2012)








#### Percent of Individuals with DD Receiving CMH Services Who Had a Fiscal Intermediary (2013)














#### 14 out of 46 CMHs had less than 5% of people using an FI




#### **3** out of 46 CMHs had **more than 20%** of people using an FI








